Achieving a modern and sustainable Medicare


- ✓ The MBS supports the delivery of over 400 million health services a year.
- ✓ Over the next 4 years the MBS will outlay over \$100 billion.
- ✓ A modern and sustainable Medicare program must support access to high-quality, appropriate and effective services.
- ✓ It must also support services that reflect current clinical evidence and contemporary best medical practice.





The MBS Review

- The MBS Review Taskforce was established in 2015.
 - ✓ Chaired by Professor Bruce Robinson
 - ✓ Includes over 70 Clinical Committees
 - ✓ Informed by over 700 independent clinicians, consumers and health system experts
 - ✓ Has reviewed more than 5,700 MBS items
 - ✓ Made over 1300 recommendations, that will change the majority of items on the Schedule
 - ✓ Amended, deleted, consolidated and added services








The MBS Review

- Reviewing and implementing changes to different MBS specialties, can take up to 3 years
 - ✓ To date, the Government has accepted and implemented approximately 350 recommendations changing over 1200 items
- 5 phases of activity
 - ✓ Initial Review
 - √ Consultation
 - ✓ Consideration by Government
 - ✓ Implementation
 - ✓ Evaluation







The MBS Review Process

- ✓ Evaluation of orthopaedic MBS items by an expert Clinical Committee.
- ✓ Review by seven sub-specialty working groups: Knee, Hand and Wrist, Shoulder and Elbow, Hip, Foot and Ankle, Paediatric and Oncology.
- ✓ Assessment of draft recommendations by the MBS Review Taskforce Chaired by Professor Bruce Robinson.
- ✓ MBS Review Taskforce Final Report released for public consultation and Government review.







- ✓ Government endorsement of recommendations.
- ✓ Implementation Liaison Groups (ILG) established to support the implementation of final recommendations.
- ✓ MBS updated to reflect the new, amended and deleted items considered as part of the review.
- Evaluation and review of implemented changes (ongoing)





Orthopaedic Surgery MBS Review – Stakeholder Consultation

- Stakeholder consultation has been an integral part of the MBS Reviews process.
- Targeted consultation on the proposed Orthopaedic Clinical Committee recommendations was conducted from 19 October 2018 to 30 November 2018.
- Feedback was received from various stakeholders, including:

Orthopaedic Surgery MBS Review – Implementation Liaison Group

- The Department of Health has worked with relevant stakeholders through the Orthopaedic Surgery Implementation Liaison Group (OSILG) to support an integrated approach to the implementation of changes to the MBS orthopaedic surgery items resulting from the MBS Review.
- The OSILG provided advice on the wording of item descriptors and explanatory notes and any unintended consequences of the changes, while maintaining the principles of the MBS Review recommendations.
- The OSILG members included representatives of orthopaedic sub-specialty, surgical assistant and plastic surgery organisations, the Australian Medical Association, the Royal Australasian College of Surgeons and private hospital and private health insurance organisations.






Summary of orthopaedic changes

- 168 new items that represent complete medical services and consolidate existing items to simplify the MBS
- 280 amended items to ensure services better reflect contemporary best practice
- 137 superseded items where services have been consolidated into new or amended items
- 9 deleted items where items are obsolete or no longer reflect clinical best practice.
- Amendments include changes to
 - Item descriptors
 - Existing explanatory notes
 - Schedule fees
 - Private Health Insurance classifications

Orthopaedic Surgery MBS Item Mapping

- A mapping document which details the changes to the orthopaedic surgery MBS items, including existing
 items and all amended items, will be available on MBS Online at: www.mbsonline.gov.au.
- The document lists all items under the relevant MBS Group and Subgroup, with amendments clearly marked in red text. Each amended item references the corresponding page of the Orthopaedic Surgery MBS Review Taskforce Report, where further information is available for each Taskforce recommendation.

- Some item descriptors may differ from the Taskforce Report recommendations. These items were considered by the Orthopaedic Surgery Implementation Liaison Group and amended to avoid any unintended consequences or service gaps.
- Note that the item descriptors are subject to legislative drafting and finalisation by the Office of Parliamentary Counsel. Some minor word changing may occur but will not alter the clinical intent.




